Dockwells Industrial Estate is located on the corner of Central Way and River Gardens on the North Feltham Trading Estate.

Central Way is off Faggs Road (A312). The M4 Motorway (junction 3) is approximately 2 miles distant providing access to Heathrow Airport, Central London and the West.

Hatton Cross Underground Station (Piccadilly Line) is approximately one mile as is Feltham Station and the town centre.
